

**Information on personal data processing rules
The 2021 CFA Society Poland Talent Workshop
Event registration application document**

We would like to inform you that:

1. The controller of your personal data is: CFA Society Poland with its registered office in Wrocław, ul. Komandorska 118/120, 53-345 (hereinafter: "CFA Society Poland" or "Controller"). The controller's contact details: phone (0048) 798 068 139, email: office@cfa.com.pl, <https://cfapoland.org/>.
2. You can contact our Data Protection Officer at any time by email: office@cfa.com.pl.
3. Your personal data are processed on the basis of your consent (Article 6(1)(a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC).
4. Your personal data are collected for the purposes of the currently conducted project The 2021 CFA Society Poland Talent Workshop, which will take place online on 13 December 2021. As part of the project, your personal data and application documents will be shared with the event partners in connection with their current recruitment processes and, if you give a separate, explicit and voluntary consent, also in connection with future recruitments.
5. The personal data and application documents provided in connection with the project The 2021 CFA Society Poland Talent Workshop are processed by the controller and by the partners for 12 months, counting from the first day of the month following the date of receipt of the application documents. The personal data provided along with the consent to their processing by the controller and by partners for the purposes of future recruitments are processed for a period of 3 years, counting from the first day of the month following the date of receipt of the application documents. After the expiry of the periods referred to in the previous sentences, or in the case of withdrawal of the consent to the processing of data for the purposes of future recruitments your data will be immediately erased or destroyed by the controller and the partners of The 2021 CFA Society Poland Talent Workshop.
6. You have the right of access to the content of your data, the right to rectification, erasure, restriction of processing, the right to data portability, the right to object, and the right to withdraw your consent to the processing.
7. You also have the right to lodge a complaint with the supervisory authority (President of the Office for Personal Data Protection).
8. It is not obligatory to agree to the processing of your data in future recruitments carried out by the partners.
9. Providing data to the extent specified in the provisions of the Act of 26 June 1974 – Labor Code and executive acts is obligatory. Providing additional personal data is voluntary.
10. Decisions made in connection with the recruitment process are not made by automated means and are not subject to profiling.

If you would like us to consider you as a candidate for future recruitments conducted by the partners of The 2021 CFA Society Poland Talent Workshop, please agree to the above by inserting the following statement:

"I consent to the processing of my personal data contained in the application documents I have provided, by The 2021 CFA Society Poland Talent Workshop, for future recruitment processes."

If you give your consent as indicated above, you will have the right to withdraw it at any time. Withdrawal of the consent does not affect the lawfulness of processing carried out on the basis of the consent before its

withdrawal. You may withdraw your consent by sending an email to office@cfa.com.pl. This consent is voluntary and does not affect the possibility of participation in the recruitment process for the given position (it will not be the basis for unfavorable treatment of the candidate and will not constitute a reason justifying refusal to hire him/her).
